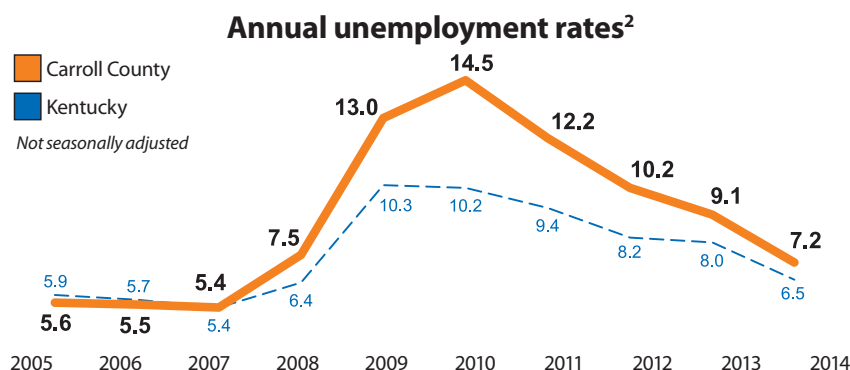
OUR FOCUS

Family and Consumer Sciences (FCS) Extension is committed to improving the health and well-being of individuals and families in Carroll County. To help Kentuckians strengthen their financial, physical, and social well-being, our educational programs focus on:

- **Making Healthy Lifestyle Choices** that influence health and well-being
- **Nurturing Families** as they cope with fewer resources and more demands
- **Embracing Life as We Age** to live independently longer
- **Securing Financial Stability** in a turbulent economic period

In 2014-2015, Family and Consumer Sciences Extension made **3,747** contacts with Carroll County individuals and families.¹

SPOTLIGHT ON...

RAIN GARDENS IMPROVE WATER QUALITY

The FCS agent presented four workshops on rain gardens and rain barrels to some 30 residents of Carroll, Boone, Grant, and Owen counties. Participants learned more about non-point source pollution, which occurs as precipitation moves over and through the ground, picking up and carrying pollutants with it to local bodies of water. A rain garden is one way homeowners can reduce their property's negative impact on water quality and flooding. A rain garden is a manmade feature that is designed to capture and reduce polluted runoff. Workshop participants reported a better understanding of landscaping best management practices.

FINANCIAL WELL-BEING

In Carroll County, the median household income in 2013 was **\$41,792 (+/- \$3,139)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **40.6% (+/-8.5)** of families with related children were below poverty
- **22.7% (+/-6.7)** of people age 65 and over were below poverty
- **5.1% (+/-2.6)** of individuals working full time/full year in the previous 12 months were below poverty
- **63.1%** of students were eligible for free lunches and **3.8%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Carroll County Extension programs:¹

- **132** youth completed Truth & Consequences: The Choice Is Yours program.
- **200** parents increased their knowledge of substance abuse resources.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Carroll County in 2012:⁶

- **13.6% (18.0%-10.0%)** of adults reported having been diagnosed with diabetes
- **38.2% (46.0%-30.8%)** of adults 18 years and over were obese
- **30.2% (38.1%-22.9%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Carroll County:⁷

- **34.2% (48.8%-22.1%)** of adults reported fair or poor health

In Carroll County:

- **69.4%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **21.9% (+/-5.7)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **16** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Carroll County Extension programs:¹

- **20** people increased knowledge of lifestyle changes to improve personal health.
- **140** people utilized healthy food delivery systems and access points.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Carroll County:⁴

- **25.6% (+/-1.8)** of households included one or more persons age 65 and over
- **148 (+/-96)** grandparents lived with and were responsible for their own grandchildren
- **77.4% (+/-11.5)** of children under 6 years and **76.2% (+/-7.9)** of children 6-17 years had all parents in the labor force
- **773 (+/-147)** of those age 5 and older spoke a language other than English at home
- **777 (+/-136)** civilian veterans lived in Carroll County⁴

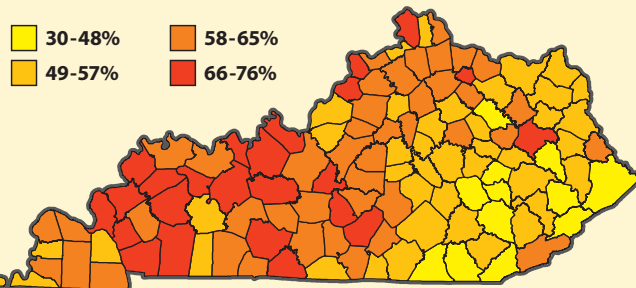
In Carroll County:

- **27.8% (44.9%-15.4%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **59** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **45.2%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Carroll County Extension programs:¹

- **12** adults reported increased leadership skills, knowledge, or confidence.
- **2,540** volunteer hours were generated.
