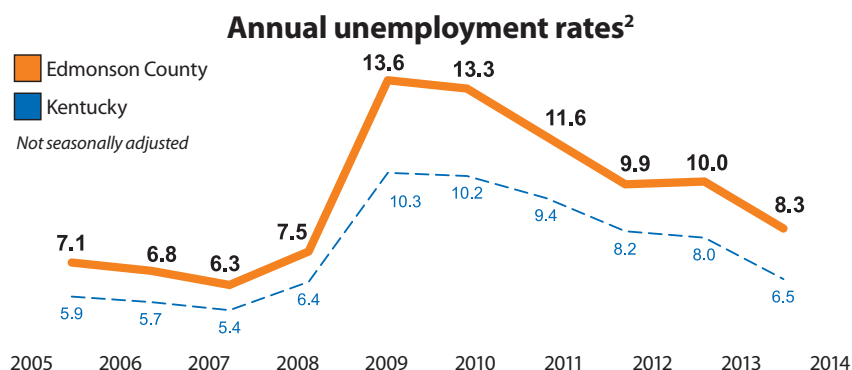
OUR FOCUS

Family and Consumer Sciences (FCS) Extension is committed to improving the health and well-being of individuals and families in Edmonson County. To help Kentuckians strengthen their financial, physical, and social well-being, our educational programs focus on:

- **Making Healthy Lifestyle Choices** that influence health and well-being
- **Nurturing Families** as they cope with fewer resources and more demands
- **Embracing Life as We Age** to live independently longer
- **Securing Financial Stability** in a turbulent economic period
- **Promoting Healthy Homes and Communities** that recycle, reduce waste, and protect our environment

In 2014-2015, Family and Consumer Sciences Extension made **3,932** contacts with Edmonson County individuals and families.¹

SPOTLIGHT ON...

FOOD PRESERVATION WORKSHOPS

Each year during the gardening season, Edmonson County residents reach out to the Cooperative Extension Service with questions about food preservation. To ensure that families got the most up-to-date, accurate, and safe information, the FCS agent held two hands-on, food preservation workshops attended by 14 people, ages 29 to 70; distributed 120 informational handouts at local events; and tested six pressure canner gauges. In a survey, all workshop participants reported that they became more knowledgeable and gained new skills and confidence related to food preservation.

FINANCIAL WELL-BEING

In Edmonson County, the median household income in 2013 was **\$36,324 (+/- \$3,350)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **12.0%** (+/-**4.8**) of families with related children were below poverty
- **11.1%** (+/-**4.3**) of people age 65 and over were below poverty
- **2.5%** (+/-**1.7**) of individuals working full time/full year in the previous 12 months were below poverty
- **54.8%** of students were eligible for free lunches and **6.3%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Edmonson County Extension programs:¹

- **400** people demonstrated informed and effective decision-making.
- **400** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Edmonson County in 2012:⁶

- **14.0%** (**17.6%-10.6%**) of adults reported having been diagnosed with diabetes
- **34.9%** (**41.9%-28.8%**) of adults 18 years and over were obese
- **33.4%** (**40.5%-27.0%**) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Edmonson County:⁷

- **35.0%** (**47.3%-24.4%**) of adults reported having been diagnosed with high blood pressure
- **33.4%** (**41.7%-26.0%**) of adults reported fair or poor health

In Edmonson County:

- **40.9%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **57.1%** (+/-**10.0**) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **12** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Edmonson County Extension programs:¹

- **100** people increased knowledge of lifestyle changes to improve personal health.
- **250** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Edmonson County:⁴

- **31.0%** (+/-**1.7**) of households included one or more persons age 65 and over
- **105** (+/-**67**) grandparents lived with and were responsible for their own grandchildren
- **76.3%** (+/-**12.7**) of children under 6 years and **56.9%** (+/-**9.9**) of children 6-17 years had all parents in the labor force
- **314** (+/-**125**) of those age 5 and older spoke a language other than English at home
- **943** (+/-**191**) civilian veterans lived in Edmonson County⁴

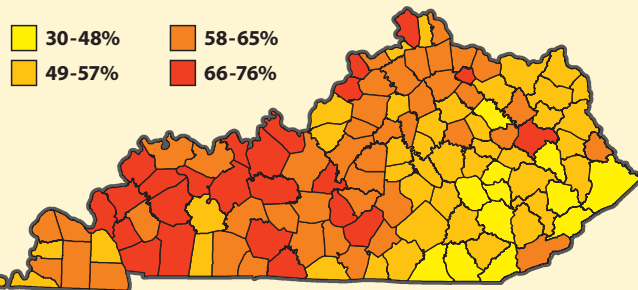
In Edmonson County:

- **29.6%** (**41.5%-19.9%**) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **53** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **49.2%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Edmonson County Extension programs:¹

- **18** adults reported increased leadership skills, knowledge or confidence.
- **150** people were reached with information related to health and safety.
