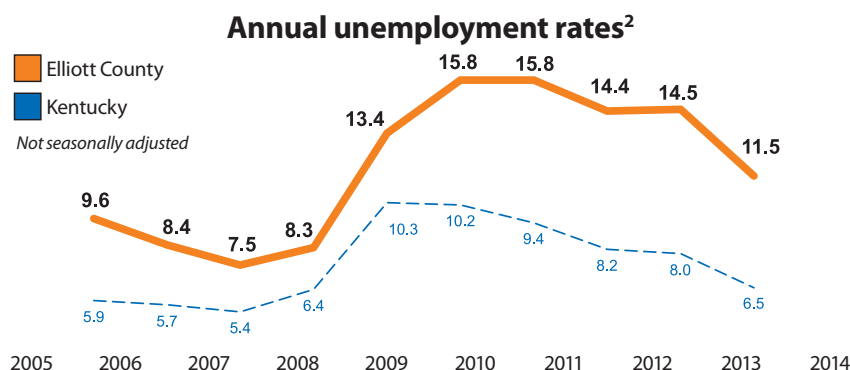
### OUR FOCUS

## DIABETES PROGRAM CHANGES LIVES

Three months after 23 people completed the Taking Ownership of Your Diabetes program, 12 are still working toward their goals. One said, "The week after the classes, I visited a diabetes educator who helped me create a diet and exercise program. I've lost 10 pounds. I know I'm just beginning, but I can do this because of what I learned. I think of the notebook you gave me and the information from the diabetes educator as my bible. I feel better and I'm proud of myself. My husband works away from home, but he encourages me with a phone call every day and on weekends we get outside and walk together."

## FINANCIAL WELL-BEING

In Elliott County, the median household income in 2013 was **\$29,544 (+/- \$2,918)** compared to \$43,307 (+/- \$631) for the state.<sup>3</sup>

The American Community Survey estimates that between 2009-2013:<sup>4</sup>

- **32.0% (+/-10.0)** of families with related children were below poverty
- **23.7% (+/-8.7)** of people age 65 and over were below poverty
- **1.6% (+/-1.7)** of individuals working full time/full year in the previous 12 months were below poverty
- **76.7%** of students were eligible for free lunches and **2.4%** were eligible for reduced-price lunches in 2014-2015<sup>5</sup>

### As a result of participating in Elliott County Extension programs:<sup>1</sup>

- **31** people demonstrated informed and effective decision-making.
- **200** youth reported acquiring one or more life skills.

## PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Elliott County in 2012:<sup>6</sup>

- **12.2% (15.7%-9.2%)** of adults reported having been diagnosed with diabetes
- **34.4% (41.5%-27.7%)** of adults 18 years and over were obese
- **36.4% (44.0%-29.5%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Elliott County:<sup>7</sup>

- **40.5% (52.4%-29.5%)** of adults reported having been diagnosed with high blood pressure
- **29.6% (37.4%-22.8%)** of adults reported fair or poor health

In Elliott County:

- **42.7%** had adequate access to locations for physical activity compared to 72.0% for the state<sup>8</sup>
- **47.2% (+/-14.4)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)<sup>8</sup>
- **0-9** deaths were from a drug overdose between 2009-2013<sup>9</sup>

### As a result of participating in Elliott County Extension programs:<sup>1</sup>

- **800** people increased knowledge of lifestyle changes to improve personal health.
- **1,027** children and youth learned to eat more healthy food.

## SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Elliott County:<sup>4</sup>

- **33.7% (+/-3.5)** of households included one or more persons age 65 and over
- **121 (+/-86)** grandparents lived with and were responsible for their own grandchildren
- **53.8% (+/-15.7)** of children under 6 years and **50.2% (+/-12.9)** of children 6-17 years had all parents in the labor force
- **159 (+/-75)** of those age 5 and older spoke a language other than English at home
- **464 (+/-141)** civilian veterans lived in Elliott County<sup>4</sup>

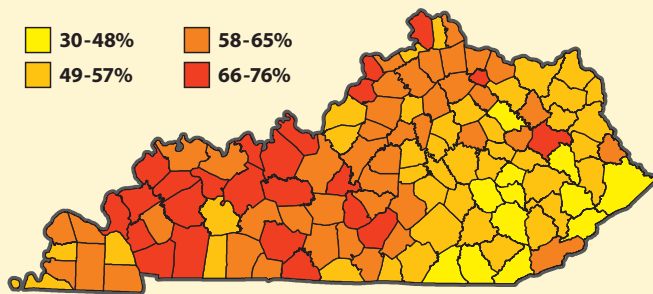
In Elliott County:

- **25.4% (35.7%-17.2%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12<sup>7</sup>
- **54** children were determined to have been victims of child abuse or neglect in 2013<sup>10</sup>
- **43.9%** of those registered to vote did so in the 2014 General Election<sup>11</sup>

### As a result of participating in Elliott County Extension programs:<sup>1</sup>

- **35** people were involved in addressing significant community issues.
- **1,042** people were reached with information related to health and safety.
