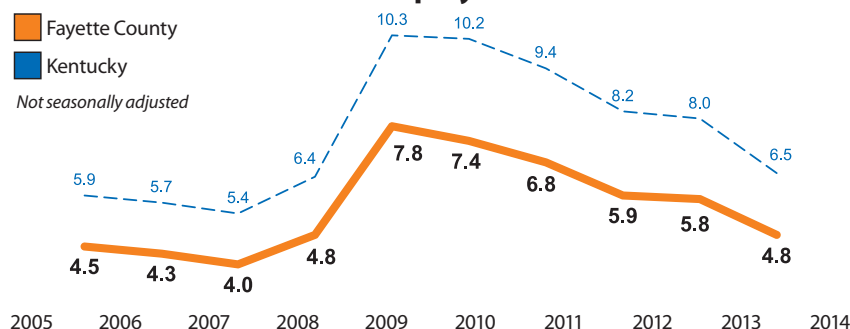
- **Making Healthy Lifestyle Choices** that influence health and well-being

SPOTLIGHT ON...

JOINING JOB CLUB PAYS OFF

On the second and fourth Tuesday, the Fayette County Cooperative Extension office is buzzing with the mantra ABN – Always Be Networking — during meetings of the Job Club, which provides strategies and career-building ideas for motivated job seekers. Job Club reached 314 people in 2014 and had an overall attendance of 975. Participants ranged from 20 to 70 years of age and had varied work experience and education. In a follow-up survey, 78% of respondents said they became employed or improved their career as a result of Job Club. Extension partners included the University of Kentucky Alumni Association, UK Human Resources, and local agencies and businesses.

FINANCIAL WELL-BEING

In Fayette County, the median household income in 2013 was **\$47,959 (+/- \$2,305)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **19.4% (+/-1.5)** of families with related children were below poverty
- **8.3% (+/-1.1)** of people age 65 and over were below poverty
- **3.6% (+/-0.5)** of individuals working full time/full year in the previous 12 months were below poverty
- **49.6%** of students were eligible for free lunches and **4.1%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Fayette County Extension programs:¹

- **4,050** people demonstrated informed and effective decision-making.
- **9,012** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Fayette County in 2012:⁶

- **9.0% (10.4%-7.7%)** of adults reported having been diagnosed with diabetes
- **26.3% (29.0%-23.8%)** of adults 18 years and over were obese
- **20.5% (22.9%-18.2%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Fayette County:⁷

- **26.8% (31.6%-22.5%)** of adults reported having been diagnosed with high blood pressure
- **13.8% (16.0%-11.9%)** of adults reported fair or poor health

In Fayette County:

- **97.2%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **18.1% (+/-0.9)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **268** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Fayette County Extension programs:¹

- **5,525** people increased knowledge of lifestyle changes to improve personal health.
- **8,200** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Fayette County:⁴

- **19.2% (+/-0.3)** of households included one or more persons age 65 and over
- **2,667 (+/-415)** grandparents lived with and were responsible for their own grandchildren
- **71.0% (+/-2.5)** of children under 6 years and **75.8% (+/-2.1)** of children 6-17 years had all parents in the labor force
- **33,447 (+/-1,056)** of those age 5 and older spoke a language other than English at home
- **17,908 (+/-740)** civilian veterans lived in Fayette County⁴

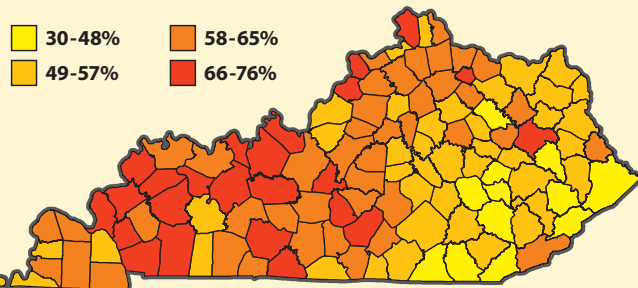
In Fayette County:

- **17.2% (20.7%-14.1%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **1,004** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **46.3%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Fayette County Extension programs:¹

- **642** adults reported increased leadership skills, knowledge or confidence.
- **11,650** people were reached with information related to health and safety.
