
OUR FOCUS

SPOTLIGHT ON...

PRESERVING FOOD PROPERLY

ome gardening and food preservation have increased in popularity in recent years due to food insecurity. The Fleming County Cooperative Extension Service offered three food preservation workshops to teach proper techniques and the latest USDA-approved canning recommendations. The 30 families that participated reported that they preserved fruits and vegetables at home after the hands-on workshops, where they made canned tomato sauce, canned beets, and apple butter. All participants said they understood the importance of preservation safety. As a result of the workshops, more than 250 pints and quarts of produce were preserved using proper food safety techniques.

FINANCIAL WELL-BEING

In Fleming County, the median household income in 2013 was **\$35,454** (+/- **\$3,472**) compared to \$43,307 (+/- \$631) for the state.3

The American Community Survey estimates that between 2009-2013:4

- 25.1% (+/-7.3) of families with related children were below poverty
- 18.2% (+/-5.1) of people age 65 and over were below poverty
- 3.5% (+/-1.8) of individuals working full time/full year in the previous 12 months were below poverty
- 61.5% of students were eligible for free lunches and 6.6% were eligible for reduced-price lunches in 2014-20155

As a result of participating in Fleming County Extension programs: 1

- 800 people demonstrated informed and effective decision-making.
- 1,250 people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Fleming County in 2012:6

- 13.1% (15.5%-10.7%) of adults reported having been diagnosed with diabetes
- 34.9% (39.5%-30.8%) of adults 18 years and over were obese
- 32.8% (37.0%-28.9%) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Fleming County:7

- 38.3% (45.1%-31.9%) of adults reported having been diagnosed with high blood pressure
- 25.1% (29.1%-21.4%) of adults reported fair or poor health

In Fleming County:

- 42.0% had adequate access to locations for physical activity compared to 72.0% for the state8
- 35.8% (+/-6.6) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 16 deaths were from a drug overdose between 2009-20139

As a result of participating in Fleming County Extension programs: 1

- 1,300 people increased knowledge of lifestyle changes to improve personal health.
- 1,200 children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Fleming County:4

- 28.2% (+/-1.5) of households included one or more persons age 65 and over
- 260 (+/-140) grandparents lived with and were responsible for their own grandchildren
- 51.3% (+/-14.5) of children under 6 years and 63.0% (+/-8.0) of children 6-17 years had all parents in the labor
- 381 (+/-219) of those age 5 and older spoke a language other than English at home
- 951 (+/-147) civilian veterans lived in Fleming County⁴


In Fleming County:

- 19.6% (25.3%-15.0%) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-127
- 112 children were determined to have been victims of child abuse or neglect in 2013¹⁰
- 47.0% of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Fleming County Extension programs: 1

- 452 adults reported increased leadership skills, knowledge or confidence.
- 1,200 people were reached with information related to health and safety.
