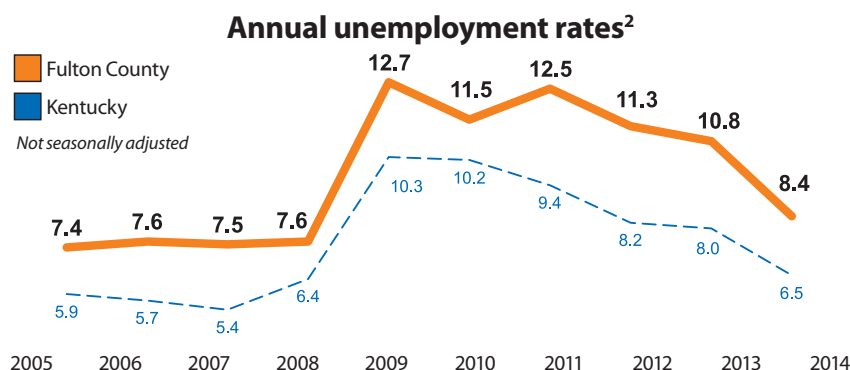
### OUR FOCUS

## HEALTH FAIR PROVIDES FREE SCREENINGS

The Cooperative Extension Service and the Haws Memorial Nursing and Rehabilitation Center planned the 2015 Health Fair. During the two-hour event, 96 participants visited 16 booths, where they could get free health screenings for their eyes, cholesterol, blood pressure, and blood oxygen. One attendee posted this on the county's Facebook page, "I commend the FCS agent and the Fulton County Cooperative Extension Service for the wonderful health fair! Great job! Everyone was so friendly and helpful. I'm very thankful to have a community with all these health services close at hand, especially after losing our hometown hospital."

## FINANCIAL WELL-BEING

In Fulton County, the median household income in 2013 was **\$28,550 (+/- \$2,698)** compared to \$43,307 (+/- \$631) for the state.<sup>3</sup>

The American Community Survey estimates that between 2009-2013:<sup>4</sup>

- **30.3% (+/-8.1)** of families with related children were below poverty
- **9.9% (+/-4.1)** of people age 65 and over were below poverty
- **6.8% (+/-3.6)** of individuals working full time/full year in the previous 12 months were below poverty
- **71.8%** of students were eligible for free lunches and **3.6%** were eligible for reduced-price lunches in 2014-2015<sup>5</sup>

### As a result of participating in Fulton County Extension programs:<sup>1</sup>

- **18** people demonstrated informed and effective decision-making.
- **984** people utilized skills learned through Extension programming.

## PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Fulton County in 2012:<sup>6</sup>

- **14.2% (18.1%-10.9%)** of adults reported having been diagnosed with diabetes
- **35.3% (42.3%-28.4%)** of adults 18 years and over were obese
- **31.4% (38.3%-24.8%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Fulton County:<sup>7</sup>

- **33.0% (47.4%-21.2%)** of adults reported fair or poor health

In Fulton County:

- **40.9%** had adequate access to locations for physical activity compared to 72.0% for the state<sup>8</sup>
- **18.6% (+/-6.5)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)<sup>8</sup>
- **0-9** deaths were from a drug overdose between 2009-2013<sup>9</sup>

### As a result of participating in Fulton County Extension programs:<sup>1</sup>

- **58** people increased knowledge of lifestyle changes to improve personal health.
- **580** children and youth learned to eat more healthy food.

## SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Fulton County:<sup>4</sup>

- **30.4% (+/-2.7)** of households included one or more persons age 65 and over
- **65 (+/-48)** grandparents lived with and were responsible for their own grandchildren
- **84.8% (+/-11.0)** of children under 6 years and **75.7% (+/-10.6)** of children 6-17 years had all parents in the labor force
- **186 (+/-111)** of those age 5 and older spoke a language other than English at home
- **494 (+/-99)** civilian veterans lived in Fulton County<sup>4</sup>

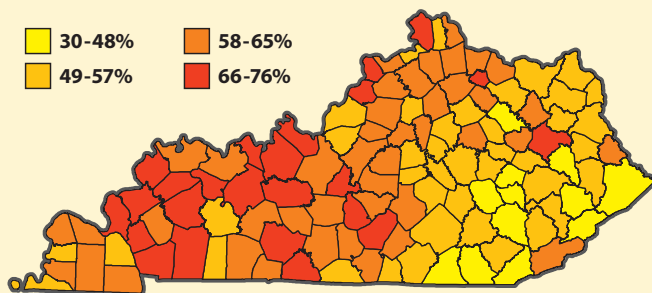
In Fulton County:

- **57** children were determined to have been victims of child abuse or neglect in 2013<sup>10</sup>
- **37.6%** of those registered to vote did so in the 2014 General Election<sup>11</sup>

### As a result of participating in Fulton County Extension programs:<sup>1</sup>

- **66** adults reported increased leadership skills, knowledge or confidence.
- **100** people were reached with information related to health and safety.
