
OUR FOCUS

SPOTLIGHT ON...

PLATE IT UP CHALLENGE

To encourage Gallatin County residents to eat more fruits and vegetables, Gallatin County Extension hosted the Kentucky Proud Plate It Up Challenge. Participants were challenged to eat more fruits and vegetables and Kentucky Proud products and prepare a Plate It Up recipe. Several programs used Plate It Up recipes, including Plate It Up Night for the County Extension Council and Cooking from the Garden. Evaluations showed that many participants prepared more than one Plate It Up recipe. All were more aware of Kentucky food products and 95% became more aware of the amount of fruits and vegetables they eat on a daily basis.

FINANCIAL WELL-BEING

In Gallatin County, the median household income in 2013 was **\$44,142** (+/- **\$4,158**) compared to \$43,307 (+/- \$631) for the state.3

The American Community Survey estimates that between 2009-2013:4

- 26.1% (+/-6.4) of families with related children were below poverty
- 16.9% (+/-7.6) of people age 65 and over were below poverty
- 4.5% (+/-3.0) of individuals working full time/full year in the previous 12 months were below poverty
- 65.6% of students were eligible for free lunches and 5.0% were eligible for reduced-price lunches in 2014-20155

As a result of participating in Gallatin County Extension programs: 1

- 110 people demonstrated informed and effective decision-making.
- 200 people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Gallatin County in 2012:6

- 11.3% (15.3%-8.0%) of adults reported having been diagnosed with diabetes
- 31.1% (38.9%-24.1%) of adults 18 years and over were
- 37.3% (46.4%-28.7%) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Gallatin County:7

• 31.2% (46.8%-18.9%) of adults reported fair or poor health

In Gallatin County:

- 8.3% had adequate access to locations for physical activity compared to 72.0% for the state8
- 44.3% (+/-9.0) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 15 deaths were from a drug overdose between 2009-20139

As a result of participating in Gallatin County Extension programs: 1

- 1,450 people increased knowledge of lifestyle changes to improve personal health.
- 900 children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Gallatin County:4

- 24.1% (+/-2.0) of households included one or more persons age 65 and over
- 124 (+/-63) grandparents lived with and were responsible for their own grandchildren
- 57.5% (+/-16.1) of children under 6 years and 56.2% (+/-12.1) of children 6-17 years had all parents in the labor force
- 424 (+/-126) of those age 5 and older spoke a language other than English at home
- 721 (+/-130) civilian veterans lived in Gallatin County⁴


In Gallatin County:

- 67 children were determined to have been victims of child abuse or neglect in 2013¹⁰
- 43.8% of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Gallatin County Extension programs: 1

- 35 adults reported increased leadership skills, knowledge or confidence.
- 1,500 people were reached with information related to health and safety.
