






# **OUR FOCUS**

# SPOTLIGHT ON...

# INMATES LEARN FINANCIAL SKILLS

In Harlan County, middle- and low-income families often have inadequate savings, too much debt and poor financial planning practices. Changing opinions and attitudes and increasing knowledge and skills can improve employability. The It's Your Reality class was offered to 31 men who were inmates in the county correctional facility and were in the substance abuse program. After completing five weeks of classes, 26 out of the 31 had a good-to-excellent understanding of what it costs to maintain a household, thanks to sessions on budgeting, money management, credit and credit cards, and debt.

# FINANCIAL WELL-BEING

In Harlan County, the median household income in 2013 was **\$25,460** (+/- **\$1,950**) compared to \$43,307 (+/- \$631) for the state.3

The American Community Survey estimates that between 2009-2013:4

- 36.3% (+/-4.9) of families with related children were below poverty
- 15.8% (+/-2.9) of people age 65 and over were below poverty
- 6.9% (+/-2.2) of individuals working full time/full year in the previous 12 months were below poverty
- 74.7% of students were eligible for free lunches and 2.8% were eligible for reduced-price lunches in 2014-2015<sup>5</sup>

## As a result of participating in Harlan County Extension programs: 1

- 1,122 people demonstrated informed and effective decision-making.
- 1,320 people demonstrated increased practical living skills.

## PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Harlan County in 2012:6

- 15.4% (18.7%-12.4%) of adults reported having been diagnosed with diabetes
- 36.6% (42.0%-31.3%) of adults 18 years and over were obese
- 40.1% (45.6%-34.9%) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Harlan County:7

- 43.1% (51.3%-35.2%) of adults reported having been diagnosed with high blood pressure
- 37.2% (43.0%-31.8%) of adults reported fair or poor health

#### In Harlan County:

- 54.2% had adequate access to locations for physical activity compared to 72.0% for the state8
- 29.1% (+/-4.3) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 62 deaths were from a drug overdose between 2009-20139

## As a result of participating in Harlan County Extension programs: 1

- 1,125 people increased knowledge of lifestyle changes to improve personal health.
- 70 children and youth learned to eat more healthy food.

# **SOCIAL WELL-BEING**

The American Community Survey estimates that between 2009-2013 in Harlan County:4

- 28.0% (+/-1.1) of households included one or more persons age 65 and over
- 573 (+/-182) grandparents lived with and were responsible for their own grandchildren
- 33.8% (+/-7.4) of children under 6 years and 46.2% (+/-5.7) of children 6-17 years had all parents in the labor
- 367 (+/-95) of those age 5 and older spoke a language other than English at home
- 2,176 (+/-234) civilian veterans lived in Harlan County<sup>4</sup>


### In Harlan County:

- 29.6% (38.6%-21.9%) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-127
- 100 children were determined to have been victims of child abuse or neglect in 2013<sup>10</sup>
- 45.4% of those registered to vote did so in the 2014 General Election<sup>11</sup>

## As a result of participating in Harlan County Extension programs:1

- 200 adults reported increased leadership skills, knowledge or confidence.
- 1,500 people were reached with information related to health and safety.
