
OUR FOCUS

SPOTLIGHT ON...

HOMEMAKERS ENCOURAGE YOUTH

ne goal of the Harrison County Extension Homemakers is to encourage youth. As part of the 2015 Homemakers' Annual Meeting, one former and three current 4-H members were asked to talk about how Cooperative Extension has influenced their life. The youth talked about their decisions to pursue interests in areas such as the beef cattle industry; merchandising; apparel and textiles; leadership; and auctioning. All of the youth have received special recognition for their skills. Being asked to speak to the group showed the youth they have the community's support. All said they intend to stay active in the Extension Service.

FINANCIAL WELL-BEING

In Harrison County, the median household income in 2013 was **\$42,228** (+/- **\$3,631**) compared to \$43,307 (+/- \$631) for the state.3

The American Community Survey estimates that between 2009-2013:4

- 28.9% (+/-6.3) of families with related children were below poverty
- 17.5% (+/-5.4) of people age 65 and over were below poverty
- 3.7% (+/-1.4) of individuals working full time/full year in the previous 12 months were below poverty
- 56.1% of students were eligible for free lunches and 5.1% were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Harrison County Extension programs: 1

- 745 people demonstrated informed and effective decision-making.
- 625 people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Harrison County in 2012:6

- 12.2% (15.9%-9.0%) of adults reported having been diagnosed with diabetes
- 29.8% (36.8%-23.7%) of adults 18 years and over were
- 29.1% (35.9%-22.6%) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Harrison County:7

• 19.7% (31.1%-11.7%) of adults reported fair or poor health

In Harrison County:

- 42.6% had adequate access to locations for physical activity compared to 72.0% for the state8
- 38.8% (+/-5.9) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 15 deaths were from a drug overdose between 2009-20139

As a result of participating in Harrison County Extension programs: 1

- 512 people increased knowledge of lifestyle changes to improve personal health.
- 565 children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Harrison County:4

- 28.1% (+/-1.6) of households included one or more persons age 65 and over
- 382 (+/-144) grandparents lived with and were responsible for their own grandchildren
- **62.5%** (+/-**12.6**) of children under 6 years and **72.1%** (+/-8.7) of children 6-17 years had all parents in the labor
- 618 (+/-153) of those age 5 and older spoke a language other than English at home
- 1,562 (+/-263) civilian veterans lived in Harrison County⁴


In Harrison County:

- 53 children were determined to have been victims of child abuse or neglect in 2013¹⁰
- 45.9% of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Harrison County Extension programs: 1

- 325 adults reported increased leadership skills, knowledge or confidence.
- 520 people were reached with information related to health and safety.
