
# **OUR FOCUS**

# BACKPACK PROGRAM FILLS EMPTY TUMMIES

The Hart County Backpack Program serves 120 schoolchildren who have been identified as at-risk for hunger by teachers, administrators, and family resource center staff. The students receive a bag of food each Friday that includes ready-to-eat items. The cost per child for one school year is \$100, which is funded through donations and fundraisers. School personnel say children's behavior improves when they aren't hungry. One staff member said parents tell her that the food helps stretch the groceries for their families. Another teacher asked a new student about the program, and he replied, "My tummy no longer hurts."

# FINANCIAL WELL-BEING

In Hart County, the median household income in 2013 was \$33,588 (+/- \$3,021) compared to \$43,307 (+/- \$631) for the state.3

The American Community Survey estimates that between 2009-2013:4

- 35.4% (+/-6.1) of families with related children were below poverty
- 19.4% (+/-4.4) of people age 65 and over were below poverty
- 7.0% (+/-2.2) of individuals working full time/full year in the previous 12 months were below poverty
- 60.7% of students were eligible for free lunches and 6.2% were eligible for reduced-price lunches in 2014-20155

## As a result of participating in Hart County Extension programs: 1

- 476 people demonstrated informed and effective decision-making.
- 539 people demonstrated increased practical living skills.

## PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Hart County in 2012:6

- 13.5% (17.2%-10.6%) of adults reported having been diagnosed with diabetes
- 35.2% (41.6%-29.4%) of adults 18 years and over were obese
- 33.6% (40.2%-27.4%) of adults reported no leisure-time exercise in the past month

#### Between 2006-2012 in Hart County:7

- 41.6% (53.6%-30.5%) of adults reported having been diagnosed with high blood pressure
- 25.2% (31.8%-19.6%) of adults reported fair or poor health

#### In Hart County:

- 59.9% had adequate access to locations for physical activity compared to 72.0% for the state8
- 37.8% (+/-5.9) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 10 deaths were from a drug overdose between 2009-20139

## As a result of participating in Hart County Extension programs: 1

- 211 people increased knowledge of lifestyle changes to improve personal health.
- 446 children and youth learned to eat more healthy food.

# **SOCIAL WELL-BEING**

The American Community Survey estimates that between 2009-2013 in Hart County:4

- 28.0% (+/-1.4) of households included one or more persons age 65 and over
- 279 (+/-101) grandparents lived with and were responsible for their own grandchildren
- 40.7% (+/-11.8) of children under 6 years and 53.5% (+/-8.0) of children 6-17 years had all parents in the labor
- 1,208 (+/-305) of those age 5 and older spoke a language other than English at home
- 1,202 (+/-168) civilian veterans lived in Hart County<sup>4</sup>


### In Hart County:

- 23.8% (32.3%-17.0%) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-127
- 35 children were determined to have been victims of child abuse or neglect in 2013<sup>10</sup>
- 45.4% of those registered to vote did so in the 2014 General Election<sup>11</sup>

## As a result of participating in Hart County Extension programs:1

- 156 adults reported increased leadership skills, knowledge or confidence.
- 729 people were reached with information related to health and safety.
