
OUR FOCUS

SPOTLIGHT ON...

PREVENTING TEEN PREGNANCIES

n 2011, the U.S. Department of Health and Human Services ranked Kentucky seventh-highest in teen pregnancy. In many cases, teen pregnancies are the result of a lack of education and understanding regarding smart relationship choices. The FCS agent collaborated with All God's Children — a home for teen mothers — to deliver an 11-week program on healthy relationship building and decision-making. All of the participants said they learned new strategies and planned to use what they learned in future relationships. One participant said the program showed her that her current relationship was unhealthy, and she planned to leave the relationship.

FINANCIAL WELL-BEING

In Jessamine County, the median household income in 2013 was **\$52,011** (+/- **\$3,539**) compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:4

- 23.2% (+/-3.8) of families with related children were below poverty
- 5.3% (+/-2.2) of people age 65 and over were below poverty
- 3.6% (+/-1.0) of individuals working full time/full year in the previous 12 months were below poverty
- 48.0% of students were eligible for free lunches and 6.3% were eligible for reduced-price lunches in 2014-20155

As a result of participating in Jessamine County Extension programs: 1

- 1,200 people demonstrated informed and effective decision-making.
- 320 people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Jessamine County in 2012:6

- 10.1% (13.2%-7.6%) of adults reported having been diagnosed with diabetes
- 31.1% (37.3%-25.3%) of adults 18 years and over were obese
- 28.5% (34.6%-22.8%) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Jessamine County:⁷

- 39.5% (53.2%-27.3%) of adults reported having been diagnosed with high blood pressure
- 14.7% (23.1%-9.0%) of adults reported fair or poor health

In Jessamine County:

- 82.4% had adequate access to locations for physical activity compared to 72.0% for the state8
- 37.7% (+/-3.7) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 47 deaths were from a drug overdose between 2009-20139

As a result of participating in Jessamine County Extension programs: 1

- 500 people increased their knowledge of lifestyle changes to improve personal health.
- 1,980 children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Jessamine County:4

- 21.9% (+/-1.1) of households included one or more persons age 65 and over
- 356 (+/-118) grandparents lived with and were responsible for their own grandchildren
- **63.4%** (+/-**7.9**) of children under 6 years and **65.2%** (+/-**4.9**) of children 6-17 years had all parents in the labor
- 1,883 (+/-410) of those age 5 and older spoke a language other than English at home
- 3,237 (+/-301) civilian veterans lived in Jessamine County⁴


In Jessamine County:

- 18.5% (28.3%-11.5%) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-127
- 148 children were determined to have been victims of child abuse or neglect in 2013¹⁰
- 47.9% of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Jessamine County Extension programs: 1

- 244 adults reported increased leadership skills, knowledge or confidence.
- 1,300 people were reached with information related to health and safety.
