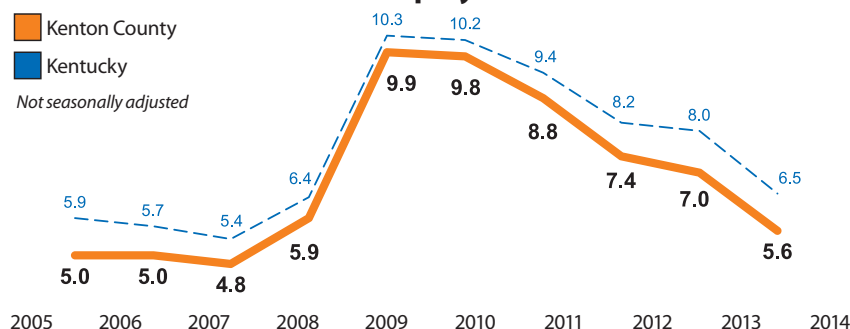
- **Making Healthy Lifestyle Choices** that influence health and well-being

SPOTLIGHT ON...

THINKING ABOUT TOMORROW TODAY

Seniors make up 13.3% of Kentucky's population and that percentage is expected to double in the next 40 years. To address the issues of aging, the Kenton and Boone County FCS extension agents presented Thinking About Tomorrow, a series of talks where experts and Cooperative Extension specialists covered topics including Leaving a Legacy, Financial Issues and Aging, Legal Considerations for Aging, and Funeral Homes. After the programs, 58% of 108 participants designated a power of attorney, talked with family about important documents, completed or updated their will, and considered their funeral wishes. Participants also reviewed their banking beneficiaries, insurance and saving plans, and made plans to "gift" personal items.

FINANCIAL WELL-BEING

In Kenton County, the median household income in 2013 was **\$53,949 (+/- \$2,391)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **17.4% (+/-2.0)** of families with related children were below poverty
- **8.3% (+/-1.6)** of people age 65 and over were below poverty
- **2.1% (+/-0.4)** of individuals working full time/full year in the previous 12 months were below poverty
- **47.1%** of students were eligible for free lunches and **5.2%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Kenton County Extension programs:¹

- **182** people demonstrated informed and effective decision-making.
- **1,225** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Kenton County in 2012:⁶

- **9.5% (11.2%-8.1%)** of adults reported having been diagnosed with diabetes
- **27.8% (31.2%-24.7%)** of adults 18 years and over were obese
- **23.8% (26.7%-20.9%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Kenton County:⁷

- **27.8% (32.7%-23.3%)** of adults reported having been diagnosed with high blood pressure
- **15.7% (18.4%-13.4%)** of adults reported fair or poor health

In Kenton County:

- **83.7%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **25.6% (+/-1.6)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **296** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Kenton County Extension programs:¹

- **1,000** people increased knowledge of lifestyle changes to improve personal health.
- **628** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Kenton County:⁴

- **21.3% (+/-0.5)** of households included one or more persons age 65 and over
- **1,648 (+/-286)** grandparents lived with and were responsible for their own grandchildren
- **68.8% (+/-4.0)** of children under 6 years and **75.0% (+/-3.2)** of children 6-17 years had all parents in the labor force
- **6,198 (+/-623)** of those age 5 and older spoke a language other than English at home
- **11,814 (+/-611)** civilian veterans lived in Kenton County⁴

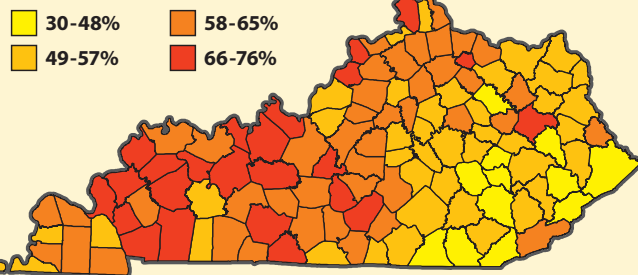
In Kenton County:

- **19.5% (23.4%-16.1%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **1,001** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **38.8%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Kenton County Extension programs:¹

- **103** adults reported increased leadership skills, knowledge or confidence.
- **2,491** people were reached with information related to health and safety.
