
# **OUR FOCUS**

# SCHOOL STAFF LEARNS KEYS TO HEALTHY LIVING

uring a seven-week period, the Knott County FCS agent provided information to 20 school staff about healthy eating habits, using MyPlate, exercise, and healthy ways to dine out. Total weight loss for the group during the program was 10%. Participants said the keys were to eat more fruits and vegetables, practice portion control, and be physically active. The most gratifying example was a cook who lost 7.8% of her body weight by eating more healthfully and by walking. She plans to continue those practices to improve her health.

# FINANCIAL WELL-BEING

In Knott County, the median household income in 2013 was **\$32,294** (+/- **\$2,306**) compared to \$43,307 (+/- \$631) for the state.3

The American Community Survey estimates that between 2009-2013:4

- 27.9% (+/-6.6) of families with related children were below poverty
- 13.4% (+/-4.3) of people age 65 and over were below poverty
- 3.7% (+/-1.7) of individuals working full time/full year in the previous 12 months were below poverty
- 74.5% of students were eligible for free lunches and 4.1% were eligible for reduced-price lunches in 2014-20155

## As a result of participating in **Knott County Extension programs:** 1

- 949 people demonstrated informed and effective decision-making.
- 2,404 people demonstrated increased practical living skills.

# PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Knott County in 2012:6

- 15.0% (18.3%-11.9%) of adults reported having been diagnosed with diabetes
- 40.7% (46.3%-35.3%) of adults 18 years and over were obese
- 37.6% (43.8%-32.0%) of adults reported no leisure-time exercise in the past month

#### Between 2006-2012 in Knott County:7

- 34.3% (42.4%-27.0%) of adults reported having been diagnosed with high blood pressure
- 35.0% (40.7%-29.8%) of adults reported fair or poor health

#### In Knott County:

- 47.7% had adequate access to locations for physical activity compared to 72.0% for the state8
- 40.0% (+/-7.5) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 45 deaths were from a drug overdose between 2009-20139

# As a result of participating in **Knott County Extension programs:**1

- 2,125 people increased knowledge of lifestyle changes to improve personal health.
- 3,113 children and youth learned to eat more healthy food.

# **SOCIAL WELL-BEING**

The American Community Survey estimates that between 2009-2013 in Knott County:4

- 26.4% (+/-1.5) of households included one or more persons age 65 and over
- 362 (+/-144) grandparents lived with and were responsible for their own grandchildren
- 52.0% (+/-10.3) of children under 6 years and 54.8% (+/-8.0) of children 6-17 years had all parents in the labor
- 205 (+/-85) of those age 5 and older spoke a language other than English at home
- 755 (+/-158) civilian veterans lived in Knott County<sup>4</sup>


### In Knott County:

- 23.7% (29.6%-18.6%) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-127
- 97 children were determined to have been victims of child abuse or neglect in 2013<sup>10</sup>
- 36.8% of those registered to vote did so in the 2014 General Election<sup>11</sup>

## As a result of participating in **Knott County Extension programs:**1

- 151 adults reported increased leadership skills, knowledge or confidence.
- 6,786 people were reached with information related to health and safety.
