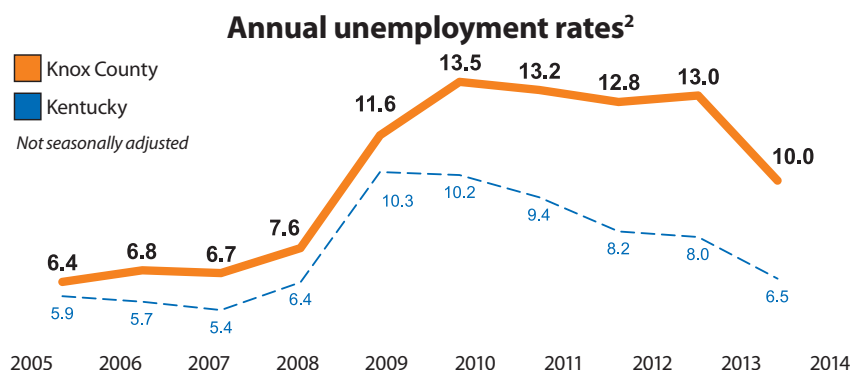
OUR FOCUS

Family and Consumer Sciences (FCS) Extension is committed to improving the health and well-being of individuals and families in Knox County. To help Kentuckians strengthen their financial, physical, and social well-being, our educational programs focus on:

- **Making Healthy Lifestyle Choices** that influence health and well-being
- **Nurturing Families** as they cope with fewer resources and more demands
- **Embracing Life as We Age** to live independently longer
- **Securing Financial Stability** in a turbulent economic period

In 2014-2015, Family and Consumer Sciences Extension made **3,553** contacts with Knox County individuals and families.¹

SPOTLIGHT ON...

PRODUCE SAMPLES ENCOURAGE EXPERIMENTATION

Until the Knox County Farmers' Market opened, fresh local produce wasn't easily accessible for many residents. To get them to try produce, the Knox County FCS Extension Program, working with the farmers' market, set up a booth to offer Plate It Up! Kentucky Proud recipe samples to market patrons. Many taste-testers commented that without these samples they would not be inclined to try certain vegetables and because of these samples they were more motivated to try new foods. Other remarks included: "I can't wait to have my mom make this for dinner!" and "My family loved your last recipe so much we've eaten it three times this month."

FINANCIAL WELL-BEING

In Knox County, the median household income in 2013 was **\$26,220 (+/- \$2,451)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **45.3% (+/-7.1)** of families with related children were below poverty
- **21.4% (+/-4.0)** of people age 65 and over were below poverty
- **9.2% (+/-3.0)** of individuals working full time/full year in the previous 12 months were below poverty
- **75.8%** of students were eligible for free lunches and **3.9%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Knox County Extension programs:¹

- **680** people demonstrated informed and effective decision-making.
- **1,500** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Knox County in 2012:⁶

- **14.9% (18.3%-11.8%)** of adults reported having been diagnosed with diabetes
- **36.7% (42.3%-31.1%)** of adults 18 years and over were obese
- **34.1% (39.6%-28.7%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Knox County:⁷

- **40.6% (49.7%-32.1%)** of adults reported having been diagnosed with high blood pressure
- **31.0% (36.6%-26.0%)** of adults reported fair or poor health

In Knox County:

- **49.0%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **21.0% (+/-4.7)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **69** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Knox County Extension programs:¹

- **750** people increased knowledge of lifestyle changes to improve personal health.
- **450** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Knox County:⁴

- **28.5% (+/-1.3)** of households included one or more persons age 65 and over
- **414 (+/-147)** grandparents lived with and were responsible for their own grandchildren
- **54.8% (+/-11.0)** of children under 6 years and **55.8% (+/-8.8)** of children 6-17 years had all parents in the labor force
- **432 (+/-340)** of those age 5 and older spoke a language other than English at home
- **1,564 (+/-235)** civilian veterans lived in Knox County⁴

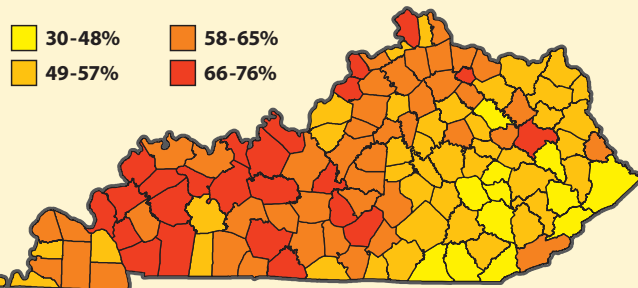
In Knox County:

- **29.0% (36.7%-22.3%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **147** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **45.9%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Knox County Extension programs:¹

- **95** adults reported increased leadership skills, knowledge or confidence.
- **802** people were reached with information related to health and safety.
