
OUR FOCUS

SPOTLIGHT ON...

WORKSHOPS ADDRESS WOMEN'S HEALTH

Today's changing health care climate means that people, especially women, must advocate for themselves. The Hot Women and Health workshops address women's health education. This year's topics were Operation Medicine Cabinet, Are You Prepared? and Gardening the Safe and Healthy Way. Surveys show that all participants learned how to dispose of unused medication; understand the purpose of living wills and Do Not Resuscitate orders; and know how to use gardening tools to protect their backs and muscles; 86% were better at managing their medications; 74% get regular screenings and checkups; and 60% were completing a living will and DNR order.

FINANCIAL WELL-BEING

In Madison County, the median household income in 2013 was **\$44,845** (+/- **\$2,825**) compared to \$43,307 (+/- \$631) for the state.3

The American Community Survey estimates that between 2009-2013:4

- 21.2% (+/-2.7) of families with related children were below poverty
- 10.8% (+/-2.2) of people age 65 and over were below poverty
- 4.6% (+/-0.9) of individuals working full time/full year in the previous 12 months were below poverty
- 46.3% of students were eligible for free lunches and 5.7% were eligible for reduced-price lunches in 2014-20155

As a result of participating in Madison County Extension programs: 1

- 989 people demonstrated informed and effective decision-making.
- 1,941 people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Madison County in 2012:6

- 10.3% (12.9%-8.1%) of adults reported having been diagnosed with diabetes
- 29.6% (34.3%-25.3%) of adults 18 years and over were obese
- 28.2% (32.6%-24.0%) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Madison County:7

- 30.2% (40.8%-21.3%) of adults reported having been diagnosed with high blood pressure
- 16.3% (21.3%-12.3%) of adults reported fair or poor health

In Madison County:

- 73.6% had adequate access to locations for physical activity compared to 72.0% for the state8
- 30.4% (+/-2.4) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 85 deaths were from a drug overdose between 2009-20139

As a result of participating in Madison County Extension programs: 1

- 5,433 people increased knowledge of lifestyle changes to improve personal health.
- 4,101 children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Madison County:4

- 22.3% (+/-0.6) of households included one or more persons age 65 and over
- 1,022 (+/-266) grandparents lived with <u>and</u> were responsible for their own grandchildren
- 67.7% (+/-4.9) of children under 6 years and 75.4% (+/-3.9) of children 6-17 years had all parents in the labor
- 2,386 (+/-384) of those age 5 and older spoke a language other than English at home
- 5,769 (+/-412) civilian veterans lived in Madison County⁴


In Madison County:

- 17.3% (27.0%-10.6%) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-127
- 399 children were determined to have been victims of child abuse or neglect in 2013¹⁰
- 45.9% of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Madison County Extension programs:1

- 102 adults reported increased leadership skills, knowledge or confidence.
- 797 people were reached with information related to health and safety.
