
OUR FOCUS

SPOTLIGHT ON...

SERIES TOUTS GROWING AND COOKING PRODUCE

The FCS Extension agent, the Expanded Food and Nutrition Program assistant, and Agriculture and Natural Resources agent offered a six-session series from May to October on container gardening and cooking. The FCS agent discussed nutrients in produce and different ways to cook and preserve produce. Plate It Up! Kentucky Proud food demos were held. Participants said they learned new ways to cook or use produce, nearly all had prepared multiple Plate It Up recipes during the series, and all planned to use the recipe cards. Of those surveyed, 67% were eating more produce per day.

FINANCIAL WELL-BEING

In Marion County, the median household income in 2013 was **\$39,665** (+/- **\$3,192**) compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:4

- 21.4% (+/-5.6) of families with related children were below poverty
- 17.5% (+/-3.9) of people age 65 and over were below poverty
- 2.3% (+/-1.3) of individuals working full time/full year in the previous 12 months were below poverty
- 55.6% of students were eligible for free lunches and 7.7% were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Marion County Extension programs: 1

- 543 people demonstrated informed and effective decision-making.
- 701 people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Marion County in 2012:6

- 10.8% (13.7%-8.3%) of adults reported having been diagnosed with diabetes
- 33.1% (39.4%-27.1%) of adults 18 years and over were obese
- 25.4% (31.0%-20.4%) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Marion County:7

- 36.6% (48.7%-26.0%) of adults reported having been diagnosed with high blood pressure
- 20.6% (26.5%-15.8%) of adults reported fair or poor health

In Marion County:

- 48.1% had adequate access to locations for physical activity compared to 72.0% for the state8
- 20.0% (+/-3.8) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 19 deaths were from a drug overdose between 2009-20139

As a result of participating in Marion County Extension programs: 1

- 970 people increased knowledge of lifestyle changes to improve personal health.
- 1,296 children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Marion County:4

- 26.3% (+/-1.8) of households included one or more persons age 65 and over
- 193 (+/-93) grandparents lived with and were responsible for their own grandchildren
- 61.0% (+/-13.3) of children under 6 years and 73.5% (+/-6.7) of children 6-17 years had all parents in the labor force
- 650 (+/-227) of those age 5 and older spoke a language other than English at home
- 1,304 (+/-164) civilian veterans lived in Marion County⁴


In Marion County:

- 29.8% (40.4%-21.0%) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-127
- 37 children were determined to have been victims of child abuse or neglect in 2013¹⁰
- 46.8% of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Marion County Extension programs: 1

- 60 adults reported increased leadership skills, knowledge or confidence.
- 1,380 people were reached with information related to health and safety.
