
OUR FOCUS

WHERE DOES YOUR MONEY GO?

n Marshall County, 104 families have participated in the Managing in Tough Times program Where Does Your Money Go? It aims to improve people's well-being by starting a conversation about basic money management skills and strategies. It tackles issues that make spending plans ineffective, such as failing to include periodic expenses like insurance, property taxes, or holiday gifts. Participants have said they believe it is important to have an ongoing discussion about money management and the importance of having a spending plan when families are struggling in tough economic times.

FINANCIAL WELL-BEING

In Marshall County, the median household income in 2013 was **\$44,157** (+/- **\$3,701**) compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:4

- 15.6% (+/-4.9) of families with related children were below poverty
- 7.6% (+/-2.3) of people age 65 and over were below poverty
- 2.5% (+/-1.5) of individuals working full time/full year in the previous 12 months were below poverty
- 46.0% of students were eligible for free lunches and 5.9% were eligible for reduced-price lunches in 2014-20155

As a result of participating in Marshall County Extension programs: 1

- 400 people demonstrated informed and effective decision-making.
- 756 people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Marshall County in 2012:6

- 10.0% (12.3%-7.9%) of adults reported having been diagnosed with diabetes
- 32.5% (37.7%-27.4%) of adults 18 years and over were obese
- 29.3% (34.1%-24.7%) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Marshall County:7

- 44.8% (53.2%-36.6%) of adults reported having been diagnosed with high blood pressure
- 23.9% (29.7%-18.9%) of adults reported fair or poor health

In Marshall County:

- 70.1% had adequate access to locations for physical activity compared to 72.0% for the state8
- 26.3% (+/-4.6) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 37 deaths were from a drug overdose between 2009-20139

As a result of participating in Marshall County Extension programs: 1

- 943 people increased knowledge of lifestyle changes to improve personal health.
- 1,467 children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Marshall County:4

- 33.2% (+/-1.3) of households included one or more persons age 65 and over
- 317 (+/-144) grandparents lived with and were responsible for their own grandchildren
- **78.2%** (+/-**7.7**) of children under 6 years and **68.0%** (+/-8.5) of children 6-17 years had all parents in the labor force
- 441 (+/-156) of those age 5 and older spoke a language other than English at home
- 2,837 (+/-353) civilian veterans lived in Marshall County⁴


In Marshall County:

- 19.6% (25.0%-15.1%) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-127
- 206 children were determined to have been victims of child abuse or neglect in 2013¹⁰
- 54.9% of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Marshall County Extension programs: 1

- 151 people were involved in addressing significant community issues.
- 2,321 people were reached with information related to health and safety.
