
OUR FOCUS

Family and Consumer Sciences (FCS) Extension is committed to improving the health and well-being of individuals and families in McCracken County. To help Kentuckians strengthen their financial, physical, and social well-being, our educational programs focus on:

- **Making Healthy Lifestyle Choices** that influence health and well-being

- **Securing Financial Stability** in a turbulent economic period

In 2014-2015, Family and Consumer Sciences Extension made **35,850** contacts with McCracken County individuals and families.¹

SPOTLIGHT ON...

RECIPE CARDS BOOST SALES AT FARM STANDS

Plate it Up!, Kentucky Proud recipe cards were stocked at five farm stands throughout the selling season, which helped boost sales by up to 10%. Farm stand owners said "having the recipe cards made them look good," "gave customers new ideas for cooking," and "helped sell certain produce," especially eggplant. Customers talked to one another about which recipes they had tried. Demonstrations and tastings at the Downtown Farmers' Market, Lowertown Arts and Music Festival, and Taste of the Garden reached more than 1,500 consumers and was another way to promote Kentucky produce. Some 9,000 recipe cards were distributed through farm stands and tastings this growing season.

FINANCIAL WELL-BEING

In McCracken County, the median household income in 2013 was **\$42,069 (+/- \$2,945)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **22.9%** (+/-**3.7**) of families with related children were below poverty
- **8.7%** (+/-**2.0**) of people age 65 and over were below poverty
- **3.6%** (+/-**1.3**) of individuals working full time/full year in the previous 12 months were below poverty
- **51.4%** of students were eligible for free lunches and **6.2%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in McCracken County Extension programs:¹

- **998** people demonstrated informed and effective decision-making.
- **1,171** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in McCracken County in 2012:⁶

- **9.8%** (**11.6%-8.1%**) of adults reported having been diagnosed with diabetes
- **32.1%** (**36.2%-28.4%**) of adults 18 years and over were obese
- **27.6%** (**31.2%-24.1%**) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in McCracken County:⁷

- **35.7%** (**41.7%-30.1%**) of adults reported having been diagnosed with high blood pressure
- **20.9%** (**24.9%-17.5%**) of adults reported fair or poor health

In McCracken County:

- **78.0%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **13.4%** (+/-**1.8**) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **71** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in McCracken County Extension programs:¹

- **1,311** people increased knowledge of lifestyle changes to improve personal health.
- **1,280** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in McCracken County:⁴

- **28.9%** (+/-**0.8**) of households included one or more persons age 65 and over
- **800** (+/-**254**) grandparents lived with and were responsible for their own grandchildren
- **65.8%** (+/-**6.4**) of children under 6 years and **69.7%** (+/-**4.5**) of children 6-17 years had all parents in the labor force
- **1,951** (+/-**301**) of those age 5 and older spoke a language other than English at home
- **5,642** (+/-**434**) civilian veterans lived in McCracken County⁴

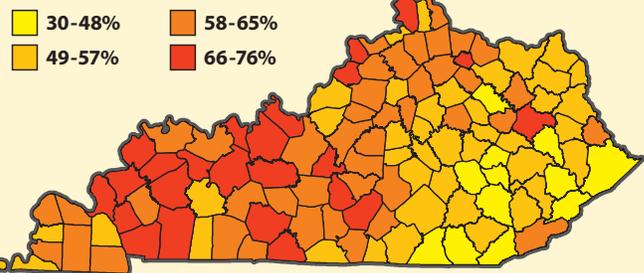
In McCracken County:

- **16.1%** (**20.7%-12.3%**) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **274** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **46.5%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in McCracken County Extension programs:¹

- **613** adults reported increased leadership skills, knowledge or confidence.
- **1,277** people were reached with information related to health and safety.
