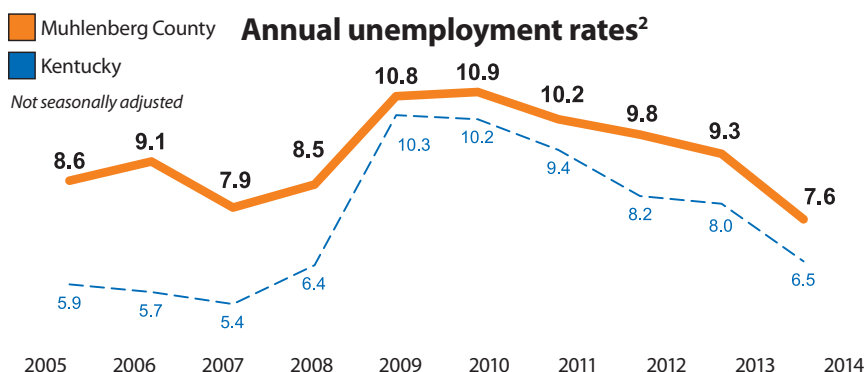
OUR FOCUS

Family and Consumer Sciences (FCS) Extension is committed to improving the health and well-being of individuals and families in Muhlenberg County. To help Kentuckians strengthen their financial, physical, and social well-being, our educational programs focus on:

- **Making Healthy Lifestyle Choices** that influence health and well-being
- **Nurturing Families** as they cope with fewer resources and more demands
- **Embracing Life as We Age** to live independently longer
- **Securing Financial Stability** in a turbulent economic period
- **Promoting Healthy Homes and Communities** that recycle, reduce waste, and protect our environment
- **Accessing Nutritious Food** that is affordable, available, and safe
- **Empowering Community Leaders** as we all work to sustain and improve our communities

In 2014-2015, Family and Consumer Sciences Extension made **13,096** contacts with Muhlenberg County individuals and families.¹

SPOTLIGHT ON...

FAMILIES LEARN ABOUT NUTRITION

The Muhlenberg County FCS agent, 4-H Youth Development agent and SNAP assistant collaborated with nursing faculty from Madisonville Community College on a five-week nutrition program for families. After enjoying weekly meals sponsored by local churches, children had nutrition education lessons while the FCS agent taught adults about financial planning, food preservation, physical activity, and nutrition. Participants said they appreciated the opportunity to come together as a community and family to learn together and become stronger families. After the program, 80% of participants said they had learned more about the topics covered.

FINANCIAL WELL-BEING

In Muhlenberg County, the median household income in 2013 was **\$37,048 (+/- \$3,495)** compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **26.2% (+/-5.0)** of families with related children were below poverty
- **9.2% (+/-2.4)** of people age 65 and over were below poverty
- **5.2% (+/-1.6)** of individuals working full time/full year in the previous 12 months were below poverty
- **53.2%** of students were eligible for free lunches and **5.5%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Muhlenberg County Extension programs:¹

- **220** people demonstrated informed and effective decision-making.
- **918** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Muhlenberg County in 2012:⁶

- **12.8% (15.7%-10.3%)** of adults reported having been diagnosed with diabetes
- **36.9% (42.3%-31.5%)** of adults 18 years and over were obese
- **32.5% (37.5%-27.9%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Muhlenberg County:⁷

- **34.1% (43.3%-25.9%)** of adults reported having been diagnosed with high blood pressure
- **20.2% (24.4%-16.5%)** of adults reported fair or poor health

In Muhlenberg County:

- **45.7%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **23.6% (+/-3.7)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **29** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Muhlenberg County Extension programs:¹

- **29** people increased knowledge of lifestyle changes to improve personal health.
- **35** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Muhlenberg County:⁴

- **29.9% (+/-1.1)** of households included one or more persons age 65 and over
- **515 (+/-181)** grandparents lived with and were responsible for their own grandchildren
- **65.0% (+/-8.9)** of children under 6 years and **63.2% (+/-7.2)** of children 6-17 years had all parents in the labor force
- **491 (+/-160)** of those age 5 and older spoke a language other than English at home
- **2,082 (+/-230)** civilian veterans lived in Muhlenberg County⁴

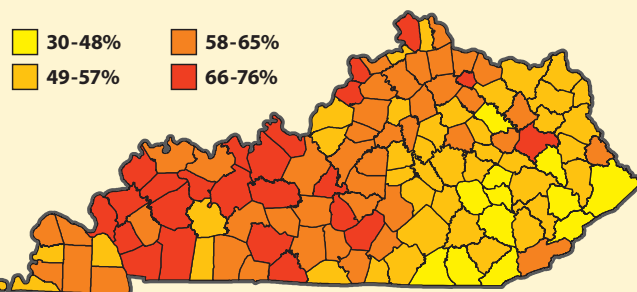
In Muhlenberg County:

- **18.6% (24.9%-13.5%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **85** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **43.9%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Muhlenberg County Extension programs:¹

- **23** adults reported increased leadership skills, knowledge or confidence.
- **83** people were reached with information related to health and safety.
