
OUR FOCUS

SPOTLIGHT ON...

CLASSES PROMOTE COOKING AT HOME

SDA studies show that families that cook and eat at home have better overall health and wellness, but a lack of cooking skills can keep them from doing so. Five Beginner's Baking, a four-part series, were held by the Pike County Extension FCS program. More than 50 families made homemade breads and evaluated their work. All of the participants learned to use recipes, measuring tools, and cooking techniques. Because of the series, participants now plan, shop, and prepare meals at home instead of purchasing premade meals or restaurant meals.

FINANCIAL WELL-BEING

In Pike County, the median household income in 2013 was **\$35,071** (+/- **\$2,587**) compared to \$43,307 (+/- \$631) for the state.3

The American Community Survey estimates that between 2009-2013:4

- 29.1% (+/-3.2) of families with related children were below poverty
- 13.3% (+/-2.2) of people age 65 and over were below poverty
- 2.9% (+/-1.0) of individuals working full time/full year in the previous 12 months were below poverty
- 61.0% of students were eligible for free lunches and 5.3% were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Pike County Extension programs: 1

- 315 people demonstrated informed and effective decision-making.
- 3,861 people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Pike County in 2012:6

- 15.2% (17.3%-13.2%) of adults reported having been diagnosed with diabetes
- 37.7% (41.3%-34.3%) of adults 18 years and over were obese
- 34.5% (38.0%-31.2%) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Pike County:7

- 42.3% (47.1%-37.6%) of adults reported having been diagnosed with high blood pressure
- 34.9% (38.2%-31.8%) of adults reported fair or poor health

In Pike County:

- 65.1% had adequate access to locations for physical activity compared to 72.0% for the state8
- 34.1% (+/-3.4) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 146 deaths were from a drug overdose between 2009-20139

As a result of participating in Pike County Extension programs: 1

- 5,400 people increased knowledge of lifestyle changes to improve personal health.
- 9,180 children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Pike County:4

- 26.8% (+/-0.8) of households included one or more persons age 65 and over
- 998 (+/-216) grandparents lived with and were responsible for their own grandchildren
- 38.3% (+/-6.0) of children under 6 years and 51.9% (+/-**4.0**) of children 6-17 years had all parents in the labor
- 920 (+/-178) of those age 5 and older spoke a language other than English at home
- 3,083 (+/-292) civilian veterans lived in Pike County⁴


In Pike County:

- 25.5% (29.5%-21.8%) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-127
- 279 children were determined to have been victims of child abuse or neglect in 2013¹⁰
- 40.0% of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Pike County Extension programs: 1

- 555 adults reported increased leadership skills, knowledge or confidence.
- 9,060 people were reached with information related to health and safety.
