OUR FOCUS



SPOTLIGHT ON...

CAREGIVERS PROGRAM PROVES PERTINENT

A s life expectancies increase, more people are becoming caregivers for those who live with chronic illnesses and disabilities. The FCS agent partnered with Kentucky River Foothills staff to present the county's first C.A.R.E. (Caregivers Assistance and Resource Education) seminar for 41 participants. Topics covered included nursing home admission requirements, expenses, and Medicaid qualifications. Free respite care services and dinner were provided. A local physician and an editor shared stories about their caregiving journey. When surveyed, all participants said they got valuable information, felt the program was very beneficial, would attend another program, and would encourage others to attend.



FINANCIAL WELL-BEING

In Powell County, the median household income in 2013 was **\$31,923** (+/- **\$3,185**) compared to \$43,307 (+/- \$631) for the state.3

The American Community Survey estimates that between 2009-2013:4

- 30.6% (+/-8.1) of families with related children were below poverty
- 24.2% (+/-7.4) of people age 65 and over were below poverty
- 2.5% (+/-1.9) of individuals working full time/full year in the previous 12 months were below poverty
- 69.2% of students were eligible for free lunches and 5.3% were eligible for reduced-price lunches in 2014-20155

As a result of participating in Powell County Extension programs: 1

- 728 people demonstrated informed and effective decision-making.
- 1,000 people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Powell County in 2012:6

- 12.5% (16.8%-9.0%) of adults reported having been diagnosed with diabetes
- 34.9% (43.1%-27.8%) of adults 18 years and over were
- 30.0% (38.8%-22.1%) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Powell County:7

• 22.8% (35.7%-13.5%) of adults reported fair or poor health

In Powell County:

- 81.7% had adequate access to locations for physical activity compared to 72.0% for the state8
- 47.1% (+/-8.4) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 41 deaths were from a drug overdose between 2009-20139

As a result of participating in Powell County Extension programs: 1

- 2,250 people increased knowledge of lifestyle changes to improve personal health.
- 400 children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Powell County:4

- 26.1% (+/-2.2) of households included one or more persons age 65 and over
- 360 (+/-180) grandparents lived with and were responsible for their own grandchildren
- **56.4%** (+/-**15.5**) of children under 6 years and **62.3%** (+/-9.7) of children 6-17 years had all parents in the labor
- 149 (+/-71) of those age 5 and older spoke a language other than English at home
- 656 (+/-159) civilian veterans lived in Powell County⁴


In Powell County:

- 91 children were determined to have been victims of child abuse or neglect in 2013¹⁰
- 46.4% of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Powell County Extension programs: 1

- 117 adults reported increased leadership skills, knowledge or confidence.
- 200 people were reached with information related to health and safety.
