
## **OUR FOCUS**

# KNOW THE 10 SIGNS OF ALZHEIMER'S PROGRAM

A n estimated 5.2 million Americans live with Alzheimer's disease, including more than 200,000 people under age 65. The Union County Homemakers, the Union County Health Coalition, Methodist Hospital and County Extension hosted an Alzheimer's Association lunch-and-learn program, Know the 10 Signs: Early Detection Matters, attended by 73 people. This evidence-based program included a PowerPoint presentation and speaker Helene French, community outreach coordinator, Alzheimer's Association. Methodist Hospital gave health screenings before the program.

## FINANCIAL WELL-BEING

In Union County, the median household income in 2013 was **\$44,595** (+/- **\$2,958**) compared to \$43,307 (+/- \$631) for the state.3

The American Community Survey estimates that between 2009-2013:4

- 26.7% (+/-6.6) of families with related children were below poverty
- 11.5% (+/-3.7) of people age 65 and over were below poverty
- 6.3% (+/-2.3) of individuals working full time/full year in the previous 12 months were below poverty
- 51.7% of students were eligible for free lunches and 6.8% were eligible for reduced-price lunches in 2014-2015<sup>5</sup>

### As a result of participating in Union County Extension programs: 1

- 65 people demonstrated informed and effective decision-making.
- 300 people demonstrated increased practical living skills.

## PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Union County in 2012:6

- 11.0% (14.2%-8.3%) of adults reported having been diagnosed with diabetes
- 33.2% (39.7%-27.0%) of adults 18 years and over were obese
- 29.0% (35.1%-23.4%) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Union County:7

- 36.8% (49.7%-25.6%) of adults reported having been diagnosed with high blood pressure
- 21.5% (28.9%-15.6%) of adults reported fair or poor health

#### In Union County:

- 56.6% had adequate access to locations for physical activity compared to 72.0% for the state8
- 25.7% (+/-5.4) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)8
- 28 deaths were from a drug overdose between 2009-20139

## As a result of participating in Union County Extension programs: 1

- 900 people increased knowledge of lifestyle changes to improve personal health.
- 600 children and youth learned to eat more healthy food.

## **SOCIAL WELL-BEING**

The American Community Survey estimates that between 2009-2013 in Union County:4

- 27.7% (+/-1.4) of households included one or more persons age 65 and over
- 233 (+/-102) grandparents lived with and were responsible for their own grandchildren
- 73.5% (+/-8.8) of children under 6 years and 63.6% (+/-8.4) of children 6-17 years had all parents in the labor
- 347 (+/-116) of those age 5 and older spoke a language other than English at home
- 1,253 (+/-192) civilian veterans lived in Union County<sup>4</sup>


#### In Union County:

- 12.8% (19.3%-8.3%) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-127
- 67 children were determined to have been victims of child abuse or neglect in 2013<sup>10</sup>
- 50.5% of those registered to vote did so in the 2014 General Election<sup>11</sup>

## As a result of participating in Union County Extension programs: 1

- 19 adults reported increased leadership skills, knowledge or confidence.
- 600 people were reached with information related to health and safety.
