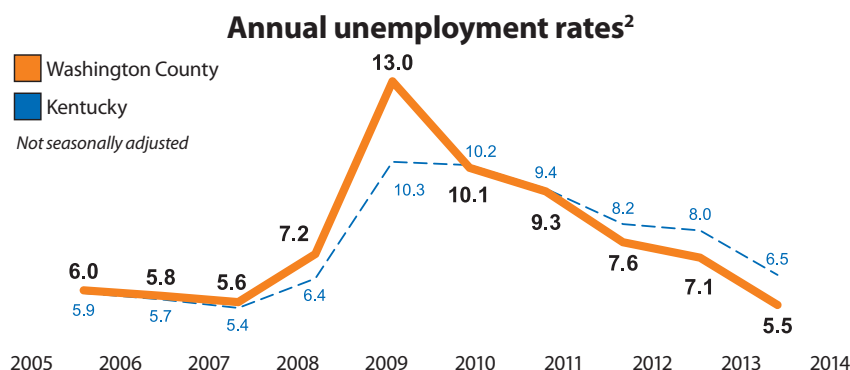
### OUR FOCUS

### SPOTLIGHT ON...

## FEEDING AMERICA FOOD PANTRY COMES TO TOWN

**L**ow-income families in Washington County need better access to fresh, nutritious food. The Washington County Cooperative Extension partnered with Feeding America, Lincoln Trail District Health Department, Washington on Wellness Coalition, Community Action, elected officials, and citizens to bring the Feeding America Mobile Food Pantry to Washington County. Fresh produce was given to 248 families and 667 individuals. Washington County Cooperative Extension will work with these partners to nourish the community through future involvement with Feeding America. Community Action commodities and food from Feeding America has been distributed each month in 2015.

## FINANCIAL WELL-BEING

In Washington County, the median household income in 2013 was **\$42,500 (+/- \$3,299)** compared to \$43,307 (+/- \$631) for the state.<sup>3</sup>

The American Community Survey estimates that between 2009-2013:<sup>4</sup>

- **18.1% (+/-5.6)** of families with related children were below poverty
- **18.3% (+/-6.2)** of people age 65 and over were below poverty
- **2.7% (+/-1.6)** of individuals working full time/full year in the previous 12 months were below poverty
- **56.9%** of students were eligible for free lunches and **8.1%** were eligible for reduced-price lunches in 2014-2015<sup>5</sup>

### As a result of participating in Washington County Extension programs:<sup>1</sup>

- **560** people demonstrated informed and effective decision-making.
- **208** people demonstrated increased practical living skills.

## PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Washington County in 2012:<sup>6</sup>

- **13.8% (17.6%-10.3%)** of adults reported having been diagnosed with diabetes
- **33.4% (40.8%-26.8%)** of adults 18 years and over were obese
- **34.8% (42.0%-27.7%)** of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Washington County:<sup>7</sup>

- **32.0% (46.8%-20.2%)** of adults reported having been diagnosed with high blood pressure
- **19.3% (26.5%-13.7%)** of adults reported fair or poor health

In Washington County:

- **20.9%** had adequate access to locations for physical activity compared to 72.0% for the state<sup>8</sup>
- **41.5% (+/-7.2)** of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)<sup>8</sup>
- **0-9** deaths were from a drug overdose between 2009-2013<sup>9</sup>

### As a result of participating in Washington County Extension programs:<sup>1</sup>

- **180** people increased knowledge of lifestyle changes to improve personal health.
- **635** children and youth learned to eat more healthy food.

## SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Washington County:<sup>4</sup>

- **27.0% (+/-1.9)** of households included one or more persons age 65 and over
- **105 (+/-74)** grandparents lived with and were responsible for their own grandchildren
- **56.7% (+/-11.2)** of children under 6 years and **73.5% (+/-9.3)** of children 6-17 years had all parents in the labor force
- **373 (+/-123)** of those age 5 and older spoke a language other than English at home
- **701 (+/-127)** civilian veterans lived in Washington County<sup>4</sup>

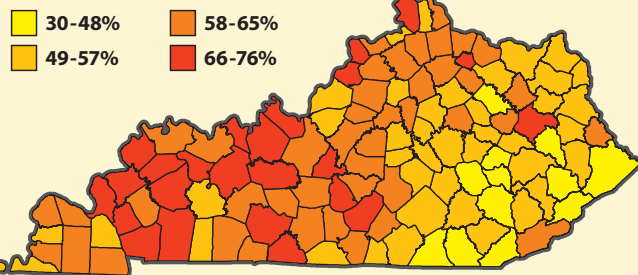
In Washington County:

- **25.6% (39.9%-15.2%)** of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12<sup>7</sup>
- **29** children were determined to have been victims of child abuse or neglect in 2013<sup>10</sup>
- **54.5%** of those registered to vote did so in the 2014 General Election<sup>11</sup>

### As a result of participating in Washington County Extension programs:<sup>1</sup>

- **165** adults reported increased leadership skills, knowledge or confidence.
- **900** people were reached with information related to health and safety.
