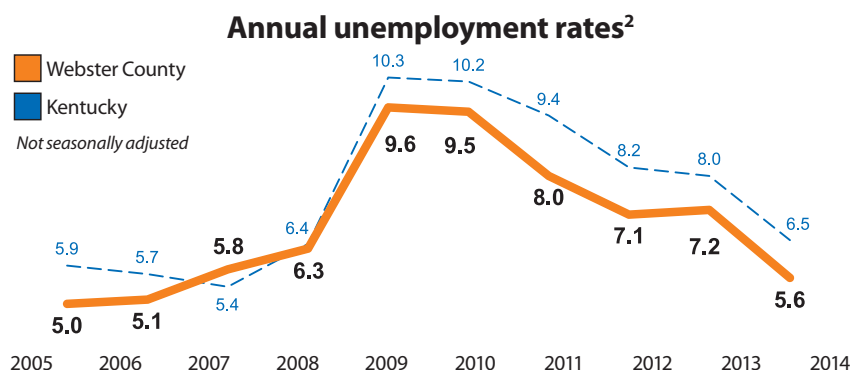
OUR FOCUS

Family and Consumer Sciences (FCS) Extension is committed to improving the health and well-being of individuals and families in Webster County. To help Kentuckians strengthen their financial, physical, and social well-being, our educational programs focus on:

- **Making Healthy Lifestyle Choices** that influence health and well-being
- **Nurturing Families** as they cope with fewer resources and more demands
- **Embracing Life as We Age** to live independently longer
- **Securing Financial Stability** in a turbulent economic period
- **Promoting Healthy Homes and Communities** that recycle, reduce waste, and protect our environment
- **Accessing Nutritious Food** that is affordable, available, and safe
- **Empowering Community Leaders** as we all work to sustain and improve our communities

In 2014-2015, Family and Consumer Sciences Extension made **8,103** contacts with Webster County individuals and families.¹

SPOTLIGHT ON...

UNIQUE PROGRAM LEADS TO LEADERSHIP OPPORTUNITIES

Two years ago, the FCS Extension agent began offering monthly Craft and App classes to promote FCS Extension programs. The classes feature a healthy appetizer (app), a Plate It Up! Kentucky Proud recipe, and affordable projects (craft). These classes have drawn people of all ages and backgrounds. Several mothers bring their children. When the classes began, 90% of the participants were not Extension Homemaker members and 50% were new to Extension. Through the class, 25% of the participants now have leadership opportunities through Extension Homemakers. One participant who was new to Extension has become a member of the Webster County Extension Council and Extension Homemakers.

FINANCIAL WELL-BEING

In Webster County, the median household income in 2013 was **\$40,881** (+/- **\$3,844**) compared to \$43,307 (+/- \$631) for the state.³

The American Community Survey estimates that between 2009-2013:⁴

- **18.7%** (+/- **6.2**) of families with related children were below poverty
- **8.4%** (+/- **3.7**) of people age 65 and over were below poverty
- **3.2%** (+/- **2.2**) of individuals working full time/full year in the previous 12 months were below poverty
- **54.5%** of students were eligible for free lunches and **4.4%** were eligible for reduced-price lunches in 2014-2015⁵

As a result of participating in Webster County Extension programs:¹

- **15** people demonstrated informed and effective decision-making.
- **610** people demonstrated increased practical living skills.

PHYSICAL WELL-BEING

According to the CDC's County Diabetes Atlas, in Webster County in 2012:⁶

- **13.2%** (**17.0%-10.1%**) of adults reported having been diagnosed with diabetes
- **33.1%** (**39.8%-26.7%**) of adults 18 years and over were obese
- **29.6%** (**36.2%-23.4%**) of adults reported no leisure-time exercise in the past month

Between 2006-2012 in Webster County:⁷

- **28.8%** (**41.5%-18.7%**) of adults reported having been diagnosed with high blood pressure
- **22.2%** (**30.1%-15.8%**) of adults reported fair or poor health

In Webster County:

- **1.7%** had adequate access to locations for physical activity compared to 72.0% for the state⁸
- **35.4%** (+/- **5.8**) of those who drive to work on their own have a commute that is more than 30 minutes (2009-2013)⁸
- **0-9** deaths were from a drug overdose between 2009-2013⁹

As a result of participating in Webster County Extension programs:¹

- **20** people increased knowledge of lifestyle changes to improve personal health.
- **900** children and youth learned to eat more healthy food.

SOCIAL WELL-BEING

The American Community Survey estimates that between 2009-2013 in Webster County:⁴

- **27.4%** (+/- **1.6**) of households included one or more persons age 65 and over
- **353** (+/- **125**) grandparents lived with and were responsible for their own grandchildren
- **50.5%** (+/- **10.8**) of children under 6 years and **59.1%** (+/- **7.4**) of children 6-17 years had all parents in the labor force
- **626** (+/- **169**) of those age 5 and older spoke a language other than English at home
- **1,070** (+/- **152**) civilian veterans lived in Webster County⁴

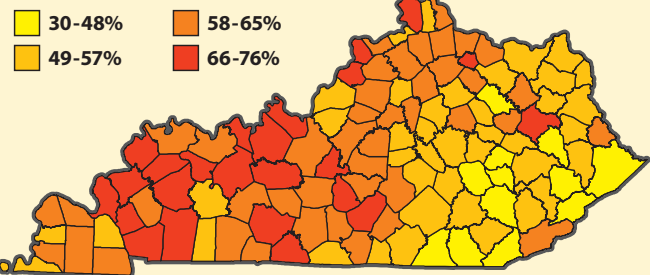
In Webster County:

- **15.9%** (**25.5%-9.4%**) of adults ages 18+ reported they did not receive sufficient social-emotional support between 2006-12⁷
- **76** children were determined to have been victims of child abuse or neglect in 2013¹⁰
- **47.9%** of those registered to vote did so in the 2014 General Election¹¹

As a result of participating in Webster County Extension programs:¹

- **27** adults reported increased leadership skills, knowledge or confidence.
- **420** people were reached with information related to health and safety.
