- **Empowering Community Leaders** as we all work to sustain and improve our communities

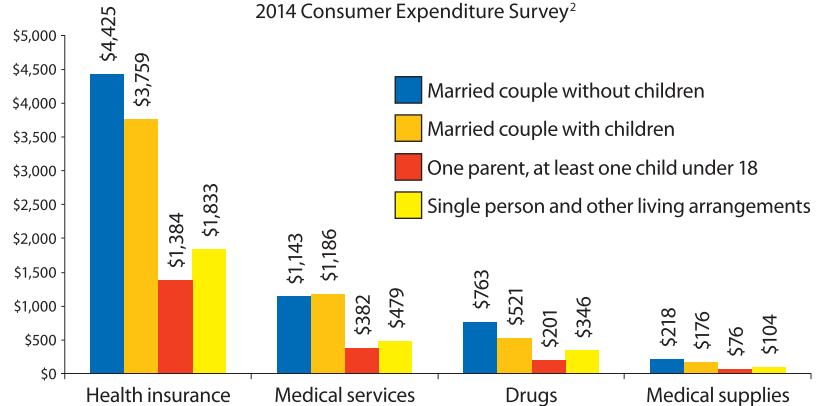
In 2015-2016, Family and Consumer Sciences Extension made **5,225** contacts with Adair County individuals and families.¹

SPOTLIGHT ON...

HEALTH CARE

When compared to housing, food, and other basic needs, routine health care costs may be a relatively small portion of the family budget. However, when a family member has an accident or is diagnosed with a chronic disease, the cost of health care can quickly impact family budgets and family relationships. Family and Consumer Sciences (FCS) Extension agents help individuals, families, and communities adopt and promote healthy behaviors to reduce health risk factors that are associated with higher health care spending and negative health outcomes.

CHILDREN AND YOUTH

In 2015 there were an estimated **4,758** youth age 19 and under in Adair County.³ By 2020, it is projected that the county will have **5,106** youth.⁴

- The U.S. Census Bureau estimates that **235 (+/-56)** youth 18 or younger were without health insurance in 2014.⁵
- Between 2010 and 2014, **62%** of pregnant women received an adequate amount of prenatal care throughout their pregnancy.⁶
- From 2011 to 2013, **7.2%** of babies weighed less than 5.5 pounds at birth.⁷
- **54%** of newborns were being breastfed at the time of hospital discharge in 2011.⁷
- **14.9%** of children between the age of 2-4 were identified as obese through the WIC program (2010).⁷

As a result of participating in Adair County Extension programs:¹

- **200** children and youth learned to eat healthier foods.
- **100** children reported eating more healthy foods.

OLDER ADULTS

In 2015 there were an estimated **3,287** adults age 65 and over in Adair County.³ By 2020, this is projected to be **3,850** persons age 65 and over.⁴ Of these, **404** are projected to be age 85 and over.⁴

According to the 2010 Census, in Adair County:⁸

- **886** individuals 65 and over lived alone
- **93** individuals 65 and over lived in nursing homes

Of Medicare fee-for-service beneficiaries in Adair County:⁹

- **9.21%** have Alzheimer's disease, related disorders, or senile dementia
- **37.85%** have arthritis
- **41.97%** have high cholesterol
- **60.67%** have hypertension
- **16.05%** have heart failure
- **28** have had a heart attack

As a result of participating in Adair County Extension programs:¹

- **1,100** people demonstrated that they used more practical living skills.
- **375** youth and adults demonstrated informed and effective decision making.

ADULTS

In 2015 there were an estimated **10,982** adults age 20-64 in Adair County.³ By 2020, it is projected that the county will have **11,096** age 20-64.⁴

The U.S. Census Bureau estimates that **14.5% (+/-1.8%)** of people age 18-64 were without health insurance in 2014.⁵

According to the County Diabetes Atlas, in 2013, **34.3% (40.9%-27.9%)** of adults were obese and **15.1% (19.0%-11.5%)** of adults had been diagnosed with diabetes.¹⁰

According to data used in the County Health Rankings:¹¹

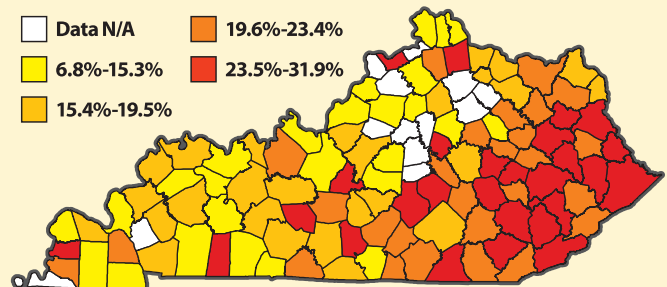
- Respondents reported an average of **5.1 (5.4-4.9)** physically unhealthy days and **4.3 (4.5-4.1)** mentally unhealthy days in the previous 30 days (2014).
- **24% (25%-23%)** of adults were current smokers (2014).
- **7** of the **21** driving deaths between 2010 and 2014 involved alcohol.

In 2015, **1-4** residents of Adair County died of a drug overdose.¹²

As a result of participating in Adair County Extension programs:¹

- **400** people were reached through health and safety programs.
- **1,500** citizens used leadership skills learned through Extension programming.
