

OUR COUNTY

- Elliott County had 1 supermarket and other grocery store and 2 convenience stores or gas stations with convenience stores in 2015.3
- According to Map the Meal Gap, in 2015, an estimated 1,480 individuals were food insecure in Elliott County.4
- Only 12.0% (25.2%-5.2%) of adults in Elliott County consumed five or more servings of fruits and vegetables per day between 2013-2015.5



of the population in Elliott County were estimated to be food insecure in 2015.4

OUR RESULTS

- 254 individuals reported eating more healthy foods.1
- 18 individuals prepared more healthy home-cooked meals.1
- 1,089 individuals used delivery systems/access points that supply healthy foods such as farmers markets, WIC*, and food pantries.1



Physical Environment

OUR COUNTY

- According to the CDC's County Diabetes Atlas, 33.7% (40.3%-27.0%) of adults 18 years and over in Elliott County were obese between 2012 and 2014.6
- The Diabetes Atlas also reports that between 2012 and 2014, 34.0% (41.4%-26.9%) of adults in Elliott County reported no leisure-time exercise in the past month.6
- There were **no** fitness and recreation businesses in Elliott County in 2015.3



of the population in Elliott County had adequate access to locations for physical activity in 2014.7

OUR RESULTS

- Extension is involved in 1 healthy lifestyle coalition.¹
- 29 individuals made changes to their diet and began exercising to improve their health.1



OUR COUNTY

- The median household income in Elliott County was \$30,299 (\$33,464-\$27,134) in 2015.8
- In Elliott County, 257 was the average monthly number of infants and children assisted by WIC* in 2013.9
- In 2015, there were **1,969** SNAP/ food stamp recipients.¹⁰
- 28.1% (+/-6.3%) of people age 65 and over were below poverty between 2011-2015¹¹ and **36.0% (43.7%-28.3%)** of children ages 5-17 in families were below poverty in 2015.8
- Between 2011 and 2015, **5.4% (+/-4.1%)** of full-time/full-year workers were below poverty.¹¹



of all children in Elliott County ages 17 and under¹² were below poverty in 2015.8

OUR RESULTS

- **\$1,056** in EBT, WIC, or senior benefits were redeemed at farmers markets.1
- 15 activities or programs have been initiated by Extensionsponsored community health coalitions.1
- **\$3,000** in funding has been received by community health coalitions.1
