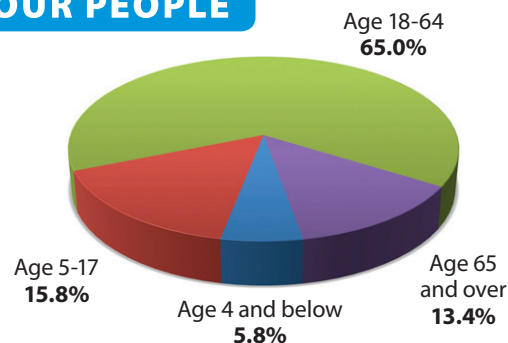
- **Making Healthy Lifestyle Choices** that influence health and well-being

In 2010-2011, Family and Consumer Sciences Extension made **32,662** contacts with Knott County individuals and families.²

SPOTLIGHT ON ...

SECURING FINANCIAL STABILITY

Following the direction of Knott County Extension Council, county agents hosted a two-part estate-planning workshop. During the first session an Extension Specialist in financial management from the University of Kentucky taught what happens if you die without an estate plan, a month later, two local attorneys discussed how to get your affairs in order according to local, state, and federal laws. 15 participants attended, with 100% reporting an increase in knowledge of estate planning. 60% said they planned to prepare a living will. By the second session 100% were in the process of preparing and/or updating an estate plan. A four-month follow-up showed that 13% had completed or updated their estate plan.

OUR FAMILIES

According to the 2010 Census,¹ of families in Knott County with their own children...

- **69.1%** are husband-wife families
- **30.9%** are single parent families

In addition, there are:

- **6,414** households
- **2,103** households with 1 or more persons under the age of 18
- **516** grandchildren under 18 years old who live with a grandparent householder
- **1,630** households with at least one person age 65 and over



As a result of participation in Knott County Extension programs:²

- **1,122** people increased knowledge of lifestyle changes to improve personal health.
- **681** people increased knowledge of parenting and personal relationships.
- **1,012** people increased knowledge of safe storage, handling and food preparation.

OUR COMMUNITY

In 2009, the most recent data available, the median household income in Knott County was **\$29,375**.³

The number of children in poverty in Knott County was **1,118** compared to **1,474** in 2006.³

The total number of people receiving Supplemental Nutrition Assistance Program (SNAP) benefits in Knott County is **5,340** in 2011.⁴

As a result of participation in Knott County Extension programs:²

- **252** people increased leadership knowledge and skills.
- **342** people improved communication skills to address community issues.
- **850** people developed skills to access affordable food.

OUR ECONOMY

According to the 2010 American Community Survey 5-year estimates,⁶ between 2005 and 2009 in Knott County it is estimated that...

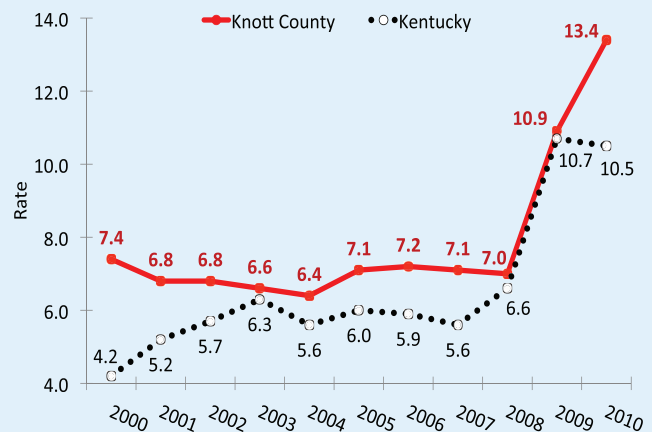
- **29.8%** (+/- **5.4**) are married-couple families with both husband and wife in the labor force
- **38.5%** (+/- **13.8**) are children under 6 years old with all parents in the labor force
- **17.4%** (+/- **4.9**) are people 65 years and over below poverty level during the past 12 months

As a result of participation in Knott County Extension programs:²

- **135** people increased knowledge of economic and enterprise development.
- **238** people adopted money management practices to reduce debt and increase savings.
- **2,057** people demonstrated increased practical living skills.
