OUR FOCUS

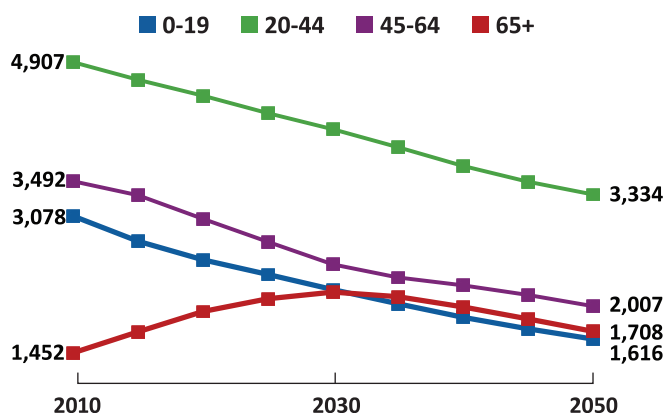
Family and Consumer Sciences Extension is committed to improving the health and well-being of individuals and families in Martin County. To help families make wise decisions our educational programs focus on:

In 2011-2012, Family and Consumer Sciences Extension made **4,983** contacts with Martin County individuals and families.²

SPOTLIGHT ON ...

INCREASING YOUTH ABILITY TO DIVERT BULLYING

Bullying is defined as an act of repeated aggressive behavior aimed at intentionally hurting another person, physically or mentally. During the school-age years, relationships with peers become the focus of a child's attention. Unfortunately, relationships at this stage can also be negative and harmful to their development. To address this issue the Martin County Cooperative Extension Service's Family and Consumer Sciences agent worked with 110 youth and family members to recognize the signs of bullying and the importance of taking a stand. In a survey: 95 percent stated that they would change their actions to make sure that they would not hurt someone else through a bullying action; and 100 percent of participants stated that they understood how their moods and emotions can affect how they treat someone.



OUR FAMILIES

According to the 2010 American Community Survey,³ between 2006 and 2010 it is estimated that in Martin County:



- **38.8% (+/- 10.8)** families with related children were below poverty
- **18.0% (+/- 6.7)** of those over the age of 65 were below poverty

In addition:

- **24.3% (+/- 2.5)** of those ages 18-64 did not have health insurance in 2010⁴
- **242** children on average received Kentucky Children's Health Insurance Program (KCHIP) benefits in 2010⁵
- **4,545** people received Supplemental Nutrition Assistance Program (SNAP) benefits in 2012⁶

As a result of participating in Martin County Extension programs:²

- **300** people were reached with the importance of physical activity.
- **450** people increased their knowledge about healthy foods.
- **417** people reported eating more healthy foods.

OUR COMMUNITY

In Martin County:

- **34.0%** of births were to mothers who received early and regular prenatal care in 2009⁷
- **56.0%** of ordered child support was collected in 2011⁸

Of the **8** primary care physicians in Martin County:⁹

- **37.5%** are family practice
- **0.0%** are pediatricians
- **0.0%** are OB/GYN

As a result of participating in Martin County Extension programs:²

- **145** people are involved in addressing community issues.
- **110** people made lifestyle changes at home to improve health.
- **95** people increased leadership knowledge and skills.

OUR HEALTH

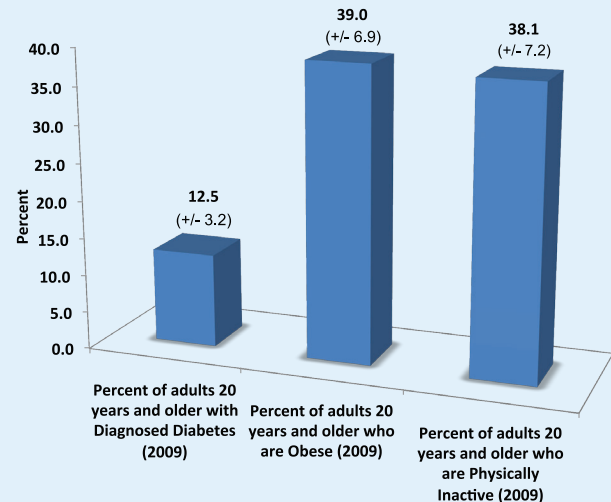
According to Kentucky Health Facts,¹⁰ between 2008 and 2010 in Martin County:

- **34.5% (22.8 - 48.5)** did not pursue health care due to cost, compared to **18% (17.0 - 18.6)** in the state
- **39.5% (27.6 - 52.8)** of adults reported their health status as less than good, compared to **23% (22.0 - 23.6)** in the state
- **30.3% (20.8 - 41.8)** of adults reported having received a flu vaccine in the past year

As a result of participating in Martin County Extension programs:²

- **320** people increased knowledge of diet and exercise changes to improve health.
- **320** people made diet or exercise changes to improve health.
- **700** people experienced a change in knowledge of healthy home practices and stress management.
